

## KETA MUNICIPAL ASSEMBLY

### IMPOSITION OF RATES AND FEE-FIXING RESOLUTION, 2023-2024

In accordance with Part VIII of the Local Governance Act, 2016 (ACT 936) the following Rates have been imposed by a Resolution of the Keta Municipal Assembly for the financial years 1<sup>st</sup> January, 2023 to 31<sup>st</sup> December, 2024.

A Basic Rate of GH C 5.00 per both male and female payable by all persons between the ages of 18 to 70 years who are residents within or own immovable property within the area of authority of the Keta Municipal Assembly.

In addition to the Basic Rate, a General Rate per Ghana Cedi of the rate-able value of immovable property situated within the administrative area of Keta Municipal Assembly except properties exempted from rating under Section 149 (2) of the Local Governance Act, 2016 (ACT 936). The amount which shall be set out in the following:
